## Letter from the Managing Editor

The publication of this issue brings a close to volume 89 of *The Pan-Pacific Entomologist*. Since I have been Managing Editor, our primary goals have been to 1) increase submissions, 2) reduce the time required to review manuscripts, and 3) return the journal to on-schedule publishing. During the first ten months of 2013 we have received 37 manuscript submissions, compared to 61 submissions in 2013 and 44 in 2011. The Richard L. Penrose Memorial Issue (volume 88, number 2) accounted for 17 of the 2012 submissions, so it appears that our submission rate for 2013 will be similar to the 2011 and adjusted 2012 rates. Despite the flat submission trend, the average review time of 2.4 months for completed 2013 submissions continues the trend for improvement (2.7 months in 2012 and 4.1 months in 2011). I am also pleased to announce our return to on-schedule publishing earlier this year after facing a 5-month deficit in early 2011. In total, volume 89 of *The Pan-Pacific Entomologist* published 32 manuscripts (25 papers, 4 scientific notes, 2 book reviews, and 1 biography) totaling 273 pages.
